### “Walk with you” – 15,500 steps Challenge”

Money raised from the event will be used for enhancing the school facilities and teaching equipment as well as for sponsoring student activities and encouraging positive learning.

#### Event details:

1. Participants : students of Queen’s College and their family members
2. Every family needs to meet the following criteria daily during the period of the event:
  - a. Aggregate of 15,500 steps per day
  - b. Each participant in the family drinking at least 8 glasses of water per day
3. The event will last from 25 February to 24 March, 2017
4. Registration fee is HK\$155 per family. A pedometer will be provided for every participant before the kick-off date. ( A kit with the pedometers will be distributed on Parents’ Day on 17-18 February at the PTA service counter)
5. Please fill up and return the attached enrollment form with registration fee and the donation raised (cash or cheque) to your class teacher before 7<sup>th</sup> February, 2017
6. Competition rules will be provided before the kick off date
7. Certificates and Awards
  1. Certificates will be presented to families which have achieved the criteria in (2) above
  2. Three awards will be presented for the following achievements
    - a. The highest step counts
    - b. The highest amount of donation raised
    - c. The highest average step counts per family
